Thank you for choosing Clermont Park District for your event. ***Please read over the following polices carefully before making your reservation.***

Please note: Yurts are rented only to organized youth groups (church, scouts, non-profits), a policy we do enforce. Any non-organized youth groups who reserve the yurts and are found to not be who they claim may be asked to leave without being refunded.

Rates

The rental rate for each of the yurts is \$75.00 each per night.

Rental Time

The yurt is available at noon on the day of reservation. Checkout time is 10 a.m. the following morning. Please contact the park district to inquire about special arrangements regarding times.

Amenities

The yurt is a **non-smoking** facility. They are equipped with electric stoves for heat, a ceiling fan and multiple electric outlets. The renter/contract holder is responsible for cleanup of the yurt, the surrounding area and for lost or stolen items. When leaving turn lights off, secure window flaps, and be sure the switch on the stove is turned off and the ceiling fan is off. Each yurt will comfortably sleep 20 – 25. There are no beds or other furniture in the yurt.

Restrooms with running water, picnic tables, grills, and a campfire circle with wood provided for overnight guests. Playground equipment, basketball court are available in the park. There are no showers, phones or refrigeration.

Suggested supplies (not exhaustive list)

- Sleeping bag, mat, or inflatable sleeping pad for each participant
- Pillow/Inflatable pillow for each participant.
- Flashlights and/or headlamps.
- Bug spray and sunscreen.
- First aid kit.

Rental Rules

The outdoor fire ring must have adult supervision at all times. Do not burn trash in the fire ring. Do not gather wood in the park or nature preserve. Keep fire small and under control.

The Chilo Lock #34 River Museum is free and open to the public. Be sure to check the website for hours, as they vary. Tours and naturalist programs can be scheduled 6 weeks in advance and are based on staff availability. Children must be accompanied by an adult in the visitor center/museum.

Trash cans are available within the park. Littering is not permitted, and a fee may be assessed if the yurt is left with significant litter surrounding it.

Per Ohio state law, beer and other alcoholic beverages are prohibited on public grounds. Fishing in the river is permitted with the proper license; all state laws must be observed.

The collection of fees, donations, offerings, or the charging of admission is prohibited on park property.

The contract holder will be held liable for all damage to plants, trees, park grounds and property resulting from the contract holder's use of the park.

No fireworks (including sparklers) permitted. Use only decorations that are easily removed by you (no glitter, confetti, silly string, sidewalk chalk, etc.)

Contract

Yurt Reservations cannot be made online. Please call 513-732-2977 in order to reserve the yurts. Credit/debit cards are accepted for payment.

The yurts must be reserved by an adult 18 years or older. The contract is non-transferable and must be in your possession at the time of the rental. Minors must be accompanied by an adult. The yurt is for your exclusive use; however, the surrounding grounds will remain open to the public. A sign will be posted by the park district indicating the time and date of your reservation. Please contact the Park District Office to set up your arrival time.
